OTHER MOTORIZED VEHICLE POLICY

Effective October 2020, update 1/21, updated 1/23

Other Motorized Vehicle (OMV) is defined as any recreational or other motorized vehicle not listed on your census form, that is intended to be driven on any Cinnamon Lake Association (CLA) road, parking lot or owner's lot. Typical vehicles include (ATV's, minibikes, Razors, snowmobiles, golf carts, etc.)

Members or associate members are required to register and have a current/valid yearly use permit from CLA for ALL OMV's owned, stored, and being used within CLA. No gate card will be issued to an OMV unless there is a current license and registration for the OMV.

No guest is permitted to bring any OMV into CLA.

Any OMV brought into CLA by a member or associate member, must be registered prior to its operation within CLA.

OMV's can be used on the roads within CLA as a mode of transportation as long as all members and their guests adhere to the following rules:

- 1) All OMV's must be registered with CLA. A unique registration sticker must be purchased along with an annual use permit sticker. These stickers along with the member's unit and lot number must be clearly visible on the vehicle, front or rear. (Unit and lot number is your four-digit address.) The unit and lot number should be no less than 3" numbers.
- 2) The 25-mph speed limit must be observed at all times. In addition, no member, associate member, or guest may operate an OMV in an unsafe manner.
- 3) Driver must have a current motor vehicle driver's license. No underage drivers are permitted to drive OMV vehicles on CLA roads.
- 4) OMVs are permitted to be driven only on member's private property or CLA roads. No one may operate an OMV on private property without written permission from the owner. No OMV's are permitted on any CLA Green Belt areas.
- 5) Members will be responsible for any guest driving the member's OMV.
- 6) Failure to comply with any of the rules will result in a violation letter and a fine.
