Fish and Lake Committee: Did you know that Fish & Lake recycles aluminum cans? Proceeds from recycling aluminum cans goes to stocking fish in the lake, buying algacide and conducting water quality tests, among many initiatives to keep our lake healthy and enjoyable. In the near future, Fish & Lake will place an aluminum recycling bin at the recycling center to compliment the one at the compactor. Don't throw your aluminum cans away, please recycle them with Fish & Lake. Cans thrown into the compactor head to the landfill; cans thrown into the county recycling bin benefit someone else; cans thrown into the Fish & Lake bin come back to help our lake. Today, 25 cans equal a dollar. The more aluminum cans recycled with Fish and Lake, the more money goes back into our lake. The **Spaghetti Dinner** is set for March 9 at 5 pm in the Lodge.
